MINUTES OF THE 2009 BIANNUAL MEETING OF THE NATIONAL COUNCIL OF CANADIAN PACIFIC PENSIONERS & SURVIVORS

The meeting was held at the downtown Calgary AB Fairmount Paliser Hotel on Friday and Saturday May 29 &30 2009.

The meeting was opened by President Don Hoare member of the Calgary chapter at 0900 hours who welcome all members delegates and the National Executive to the 2009 biannual convention, immediately after he presented the President of the Calgary AB chapter of the NCCPP, Mr. Lyle Berge who presented all major activities and locations for the convention and most of all welcome every person to Calgary AB

At 0910 Mr. Lyle Berge welcomed and introduced the President and CEO of CPR Mr. Fred GREEN who spoke to all members regarding the actual situation as follow, Company is presently living a reduction of 31 % revenue (1.5 billion \$) and maintains a bearable cost of 35 to 37% operating and 60% office and track cost, other numerous

Percentage figures as to lost traffic were given to show the decline of revenue.

The Company has created objectives so that it will help to survive this recession such as long time growth 30% parked locomotives lay off 2700 employees maintaining a clear & strong balance sheet (saving account) and pay attention to salary and bonus paid out and to sell non valuable assets or properties also to invest future worthwhile projects.

Mr. Green mentioned it will be a slow procedure to come out of this recession but their doing all possible to protect Company assets.

Mr. Green mentioned that the CPR Pension is strong and will survive and it is well administrated to recuperate in the future.

Mr.Green after his presentation agreed to answer questions from delegates and persons attending convention, questions were in regards to passenger service, coal transportation

and bond agency evaluation and major changes within the Company.

President D. Hoare thanked Mr. Green for given his precious time to inform all members present of the company situation and his belief in the company pension.

1030 hours Vice President Landry gave his blessing prayer to the convention.

1050 hours President Hoare presented Mrs. Debbie Johnson of Canadian Pacific Pension Service and Blue Cross Representative Jean Pierre Carbonneau also present Mr. Harra Burta CP Pension.

Debbie Johnson gave a power point presentation as to the number of Pensioners and survivors in all provinces also how they are served by Blue Cross, services rendered by her department and how to receive the maximum services. At this point discussion as to the letter that was sent to all pensioners and survivors regarding the Pension lost and numerous questions to the function of the fund written by Mr. Shield of Canadian Pacific from a effort of our Pension Fund Representative.

As to Mr. Carbonneau he answered numerous questions from the members to a point that the National Executive will be making a resolution to obtain further information and prices as to a provincial health Blue Cross.

1335 hours President Hoare demanded a 1 minute of silence for pass away members.

0905 hours RESOLUTIONS; President Hoare made all persons present aware that on Thursday evening May 28 2009 the National Executive meet at huit clos and review all the resolutions submitted and maintained only the following resolutions for convention.

The following resolutions were adopted for presentations to the Company and their implementation.

- 1: INDEXING: Indexing be increased from 50% to 100% of CPI on the first \$1500 of monthly pension. Also over the next five years, increase the base amount from \$1500 to \$3000 of the monthly pension. Proposed: Gary Hackney Seconded Eric Stephenson
- 2: ADHOC INCREASES: Those pensioners who have been retired for a great number of years received very minimal pensions. Therefore be it resolved that pensioners who have been retired over twenty years have an adhoc increase on the number of pensionable years and number of years since retirement. Also for pensioners who have been retired for twenty five (25) years and have 30 years of service. Proposed: George Hucker Seconded: Ron Baker
- 3: BLUE CROSS: Coverage under part 1 be adjusted to allow an increase of the \$15000. limit . Also part 2 of the plan have the current \$25000. limit increased or eliminated or consider Health spending account (H.S.A.) for all pensioners. Also have the National Council write the Blue Cross concerning the increase of part 2 Provincial Blue Cross Plan

Proposed: Robert Cameron Seconded: Lyle Burge

4: BLUE CROSS Retirees and survivors covered by Blue Cross be issued an identification card so that medication or medical treatment payable under the plan would be paid at point of purchase at the required 20% and the balance billed directly to Blue Cross.

Proposed : Gary Hackney Seconded : Peter Zmaeff

5: PUNITIVE & DESCRIMITORY ACTIONS PENSION: Remove from Company pension plan punitive & discriminatory rules or articles regarding pensioners, spouse and survivors.

Proposed : George Hucker Seconded : Robert Cameron

6: UNION NEGOTIATION: To Insure any new pension benefits that are negotiated by the unions to include all current retirees as well as future retirees.

Proposed : George Hucker Seconded : Dorothy Lancaster

7: RAILWAY PASSES: Be it resolved that all retirees who still posses a railway pass, be given the option to enroll in part 1 blue cross coverage in exchange for the pass .Also enroll in part II ,which are paid for the retiree. This would be a one time offer to exchange .

Proposed George Hucker Seconded : Frank Mark

8: 12.09 SPOUSE MORE THAN 10 YEARS YOUNGER THAN PENSIONER. Therefore be it resolved that rule 12.09 as stated should be reviewed again in the pension committee to try and resolve this discrimination.

9 : PENSIONER REPRESENTATIVE : Whereas there is only one(1) pension representative be it resolved that we have an assistant representative in a non voting capacity to obtain a working knowledge of pension duties this individual will be appointed by the National Council NCCPP .

Proposed: Peter Landry Seconded: Frank Mark

10; PERSONAL AGREEMENT: Be it resolved that a pensioner receiving a pension cheque from CP pension services be able if he or she chooses to split their monthly pension cheque with their spouse, effective as soon as they sign the agreement with the Canadian Pacific Railway Pension Department.

Proposed : Robert Cameron Seconded : George Hucker

Resolutions terminated at 1120 hours.

1045 hours President D" Hoare presented speaker Mr. Dough Finnson Vice President Teamster Union Running Trade also a member of Canadian Pacific Pension Board Committee work numerous years with Henry Thiessen. Talked about the unity between railroaders and consensus in viewing the future of the railroad.

1100 hours return to resolutions.

1120 hours: Treasurer Don Jennings brought forward a motion to change by law of convention be held every two (2) years to three (3) years after discussion and vote
